1. The Purchaser agrees to buy from the Seller the following cat upon the terms and conditions of this agreement:

2. The Purchaser understands that Seller provides kittens within a \$1800 to \$2500 USD price range. A deposit of \$300.00 USD is required to reserve a kitten. Final Cost of kitten is determined solely by the seller. Pet quality kitten prices are not to exceed \$2500.00.

(a) Deposits and payments are refundable solely at Seller's discretion. Deposits may be changed to reserve a different kitten or kitten from a future litter at the purchaser's request or depending on litter availability.

(b) Payment must be received in full and cleared before shipment or delivery will occur. Cash payment is also accepted at the time of delivery or pick up.

(c) Purchaser is responsible for all costs related to shipment, delivery or pick up of the cat by age 16 weeks. If Purchaser fails to pick up or accept delivery of the cat, the buyer forfeits their reservation and all funds paid to the Seller*.

*Exceptions will only be made in advance with written approval from Seller. Boarding fees may apply.

3. The Seller and the Purchaser acknowledge and agree that the cat is being purchased as:

* If purchasing cat for show Purchaser agrees that any printed or photo reference made to said cat will include credit to Seller by using full CFA and/or TICA registered name (e.g. Lollicat "cat name" of "Purchaser's cattery name").

4. Seller agrees to have this cat neutered/spayed by a qualified and licensed veterinarian and to provide written proof from the veterinarian to the Purchaser.

5. The Seller agrees to provide to the Purchaser the cat's TICA registration papers or application for registration at the time of pick up or within 30 days.

6. The Purchaser agrees that they will not authorize or permit this cat to be declawed under any circumstances.

7. The Purchaser agrees that this cat will not be sold, leased or given to any pet

shop, research laboratory, shelter or similar facility, and that the Seller be notified immediately of any intended disposition to rehome. The Seller retains the first option to re-adopt.

8. The Purchaser agrees that this cat will not be allowed outdoors without direct supervision and restraint.

9. The Purchaser is responsible for a veterinarian health check within 3 days of possession to confirm that the cat is in good health. The Seller will supply record of vaccinations this cat has received along with the following guarantee:

(a) Cat is guaranteed for 72 hours against upper respiratory infection, fleas, worms, fungus and ear mites.

(b) If the cat dies before 5 years of age from hereditary or congenital defects, Seller agrees to replace the cat, or refund the purchase price, when Purchaser provides proof of defect in the form of a necropsy or autopsy report from a licensed veterinarian.

(c) Seller guarantees the cat does not have FELV, FIV, FIP, PKD or HCM at the time of pickup, delivery or shipment.

10. The Purchaser is responsible for all veterinarian expenses incurred while the cat is in the Purchaser's care. The Seller will not be responsible for any veterinarian expenses incurred while the cat is in the Purchaser's care.

(a) It is the purchaser's responsibility to have the cat examined by their own veterinarian within 72 hrs of receiving the kitten and before introducing kitten to any resident animals. HEALTH GUARANTEE IS VOID if introduced to any other cats not tested FELV and FIV negative within 14 days of adoption.

11. If Purchaser is found to be in breach of contract by violating any terms listed herein, purchaser agrees that their ownership is forfeit. Purchaser agrees to relinquish cat(s) back to Seller at Purchaser's expense and furthermore, pay a fine of \$3000 USD to a humane society of the seller's choosing.

(a) If legal proceedings become necessary, the Purchaser agrees that all legal and/or court proceedings take place in the State/County in which the seller resides. All legal fees incurred by seller will be paid by buyer. All terms and conditions remain in effect for the life of the cat/kitten or for as long as seller is still breeding.
