Between Lollicat Ragdolls (Hereinafter called the Seller)
and _____
(Hereinafter called the Purchaser).

1. **The Purchaser agrees to buy from the Seller the following cat upon the terms and conditions of this agreement:**
(a) Breed: Ragdoll (b) Color/markings: _____
(c) Sex: _____ (d) Birth Date: _____
(e) Sire: _____ (f) Dam: _____
2. **The Purchaser understands the Seller provides pet kittens at a flat rate of \$2500 USD. A deposit of \$300 USD is required to reserve a pet kitten. A deposit of \$1000 USD is required for a show kitten. Show kitten pricing varies. Final cost of show quality kittens is determined solely by the Seller.**

(a) Deposits and payments are refundable solely at Seller's discretion. Deposits may be changed to reserve a different kitten or kitten from a future litter at the Purchaser's request* before the kitten reaches 10 weeks of age.

*Seller will reasonably attempt to accommodate, but does not guarantee any specific color, gender, or markings unless purchasing a show quality kitten.

(b) Payment must be received in full at or before the time of pick up.

(c) Purchaser is responsible for all costs related to shipment, delivery or pick up of the cat no sooner than 12 weeks old and no later than 16 weeks of age. If Purchaser fails to pick up or accept delivery of the cat, the buyer forfeits their reservation and all funds paid to the Seller*.

*Exceptions will only be made in advance with written approval from Seller. Boarding fees may apply.

(c) Seller may choose to terminate the contract at any time for any reason before pick up at Seller's discretion. In the case the Seller terminates the sales agreement, Purchaser's deposit shall be refunded.

- 3. The Seller and the Purchaser acknowledge and agree that the the cat is being purchased as:**
(a) Pet: _____

*If purchasing cat for show Purchaser agrees that any printed or photo reference made to said cat will include credit to Seller by using full CFA and/or TICA registered name. Show quality cats are defined as free from disqualifiable traits, parentage, and markings as defined in CFAs Ragdoll breed standard. Seller does not guarantee any specific color, gender, or markings unless purchasing a cat that is show quality.

- 4. Seller agrees to have this cat neutered or spayed and microchipped by a qualified licensed veterinarian and to provide proof from the veterinarian to the Purchaser.**

- 6. The Seller agrees to provide the Purchasers the cat's TICA or CFA registration papers or application for registration at the time of pick up or within 30 days.**

- 7. The Purchaser agrees that they will not authorize or permit this cat to be declawed under *any* circumstances at any point.**

- 8. The Purchaser agrees that this cat will not be sold, leased or given to any shop, sales agent research laboratory, shelter or similar facility and the Seller be notified immediately of any intended disposition to rehome. the Seller retains the first option to re-adopt.**

- 9. The Purchaser agrees that this cat will not be allowed outdoors without direct supervision and restraint.**

- 10. The Purchaser is responsible for a veterinarian health check within 3 days of possession to confirm that the cat is in good health. The Seller will supply record of vaccinations the cat has received along with the following guarantee:**

(a) Cat is guaranteed for 72 hours against upper respiratory infection, fleas, worms, fungus and ear mites.

(b) If the cat dies before 3 years of age from hereditary or congenital defects, Seller agrees to replace the cat or refund the purchase price at seller's discretion. Purchaser must provide proof of defect in the form of a necropsy or autopsy report from a licensed veterinarian.

(c) Seller guarantees the cat does not have FELV or FIV at pick up.

- 11. The Purchaser agrees to register their cat for 30 days of Seller provided free pet insurance (or insurance of Purchaser's choosing) within 24 hours of pick up.**

12. The Purchaser is responsible for all veterinarian expenses incurred after pick up. The Seller will not be responsible for any veterinarian expenses incurred while the cat is in the Purchaser's care.

(a) It is the Purchaser's responsibility to have the cat examined by their own veterinarian within 72 hrs of receiving the cat to any resident animals. HEALTH GUARANTEE IS VOID if not examined or if introduced to any other cats not tested FELV and FIV Negative within 14 days of adoption.

13. If Purchaser is found to be in breach of contract by violating any terms listed herein, Purchaser agrees that ownership is forfeit. Purchaser agrees to relinquish cat(s) back to seller at Purchaser's expense and furthermore, pay a fine of \$5000 USD to a shelter or humane society of Seller's choosing.

(a) If legal proceedings become necessary, the Purchaser agrees that all legal and/or court proceedings take place in the State/County in which the seller resides. All legal fees and expenses incurred by the seller will be paid by the Purchaser. All terms and conditions remain in effect for the life of the cat or for as long as the seller is still breeding.
